ON A SUNNY AFTERNOON IN SEPTEMBER, amidst the lush greenery of the Music Academy of the West garden, honorees, local representatives, Board Members, and guests gathered for the 47th annual Santa Barbara Beautiful Awards that single out exemplary properties that expand the beauty of Santa Barbara as well as individuals who have made extraordinary contributions to the fabric of Santa Barbara.

“Each year the Santa Barbara Beautiful Annual Awards event provides an opportunity for the community to gather together to highlight and celebrate the latest stunning architectural structures, public art projects, and spectacular landscape designs,” shared Ginny Brush, President, Santa Barbara Beautiful. “These awards, and those given to outstanding individuals, underscore Santa Barbara’s great legacy of community engagement and dedication to preserving the beauty and quality of life in our natural and built environment.”

Prior to the awards presentation, over 240 guests enjoyed savory appetizers provided by Lorraine Lim Catering while sipping wine by Kunin Wines and listening to the music of Grupo Sol Y Mar. Guests also had an opportunity to walk the red carpet and be interviewed by local television personality John Palminteri.

Then guests adjourned to Hahn Hall for the awards ceremony where five individual awards and nine property awards were presented. The program included a short montage highlighting Santa Barbara Beautiful’s (SBB) year round activities in the community and videos featuring the award winning properties. Videos were produced by Dana Morrow of RoadShow Media and narrated by the Hon. George Eskin and Maria Elena McCall.

Mistress of Ceremonies, Hannah Beth-Jackson kept the pace quick as various property teams and individual honorees took to the stage to receive recognition.

Ginny Brush, 2011 President of Santa Barbara Beautiful, welcomed guests and thanked the planning team, headed up by Robert Adams and the entire SBB Executive committee for their efforts throughout the year. Following came welcoming remarks by Santa Barbara Mayor Helene Schneider and a poem by Santa Barbara Poet Laureate Paul J. Willis.

The first award presented that evening recognized Lady Leslie Ridley-Tree, with the Jacaranda

Award for Outstanding Community Service for her commitment, service, and gracious gifts that have honored so many people. She has engaged her unique talents to meet the needs

Property awards are an important focus of the annual event. First up was the Open Public Space Award which went to Elings Park, a 230-

acre privately funded, non-profit park that opened to the public in 1985. It was recognized for adding much needed sports fields, hiking trails, day-camps, and event spaces for the community, all while remaining environmentally responsible.

As the evening continued, individual and property awards were interspersed, with video presentations of each property.

The Business in Art Award that originates with the City Arts Advisory Committee has found a home at Santa Barbara Beautiful’s Annual Awards. The award was presented to Gary Atkins of Gary Atkins Sound Systems for creating a stronger, more vibrant arts environment in Santa Barbara, enriching and directly impacting lives through his love of the arts and his commitment to quality sound enhancement. Phyllis de Picciotto of the City Arts Advisory Committee presented Atkins an assemblage piece, by local artist Dan Levin, complete with an old radio with antennas to commemorate the award.

For a fifth year, Santa Barbara Beautiful bestowed The Playa de Santa Barbara Award for Environmental Stewardship. This year the Community Environmental Council (CEC) was recognized for inspiring our community through education and partnerships to affect and implement real-world solutions for pressing environmental issues since its inception in 1970. SB Beautiful CFO Christie Gallagher presented the award.

The next Individual Award was the Heritage Oak Award for Lifetime Achievement. The honoree, SB Airport Director Karen Ramsdell, received the award for her dedication in overseeing the completion of significant airport capital improvements during her tenure as Airport Director. Many of these projects enhanced the safety and functionality of the airport. Ramsdell’s dedication to a truly collaborative process culminated in the construction of the new airline terminal, a career long goal. The new terminal includes a significant public art component and is the largest construction project undertaken

by the city in the last 60 years. Hazel Johns, City of Santa Barbara Airport Department, presented the award.

Ginny Brush presented the President’s Award which went to the new Santa Barbara Airport Terminal. “It is my great honor on behalf of the Board of Directors of Santa Barbara Beautiful to present this year’s President’s Award to the new Santa Barbara Airport Terminal,” said Brush. “The architects, artisans, and fabricators through their vision and inspired creations have brought traditional materials and techniques to a new terminal for a new century.

They’ve done so with a contemporary sensibility and great authenticity that looks forward to future generations who will arrive and depart from this glorious space.” A short video of the completed project illustrated the new elegant details and public art by local artists.

Other awards included: Built Green Resource Center, Historic Revitalization; West Cabrillo Boulevard Mosaic Tiles, Hugh Petersen Award for Art in Public Places; San Ysidro Ranch, Commercial Building; Santa Barbara Harbor Entrance, Commercial Sign; Chuck’s Waterfront Grill-Patio Sail Structure, Architectural Feature; Artisan Court, Multi-Family Residence; 1057 Arbolado Road, Single Family Residence-Small; and 770 Ladera Lane, Single Family Residence-Large.

Following the awards ceremony, guests gathered at the front courtyard of Hahn Hall for a champagne toast. *Cheers to all of the 2011 Santa Barbara Beautiful award winners!*
